**Milfoil Hand Removal Dates** – we will determine some coordinated dates for shoreline removal efforts after the milfoil mapping on June 27, 2026.

**Milfoil Removal Station** – We will be meeting with the Parks Commission on June 11th to secure permission for the station. We are planning a dedication to George Klimowicz and will be including his picture on the station. Katie will be leading this initiative.
